



## Building resilience by scaling local action and strengthening legal frameworks

(Commission E)

### Objectives

Commission E will consist of two sessions and discuss two important themes for building resilience – scaling up local organization and action and strengthening legal frameworks for disasters and emergencies. In light of the large number of issues involved, each session will focus on one of these two themes.

**Session 1** (9 December, 10.00-12.00) will serve the resilience agenda and the official launch of the One Billion Coalition for Resilience (1BC) and allow participants to discuss 1BC-related issues and make pledges to support it. Supporting and facilitating the 1BC is the voluntary commitment of the International Federation of Red Cross and Red Crescent Societies (IFRC) to building the resilience of people and communities in line with the Sendai Framework for Disaster Risk Reduction 2015-2030. 1BC aims to create a world where people in every community can survive and thrive in the face of increasing risks and vulnerability. As a stepping stone toward this vision, by 2025 this new initiative will rally communities and partners to engage and inspire one billion people – in high, middle and low income countries – to take active steps to enhance their resilience<sup>1</sup>. It will help communities use a coalition-based model to strengthen civic engagement, map their capacities, understand their legal rights and obligations, tap local and external resources, facilitate collective decision-making, organize local household and small business campaigns, and create local solutions to mitigate risks to health and safety. It is a partnership approach that will engage not only the Red Cross but also governments, the United Nations, civil society, the private sector, and academia.

**Session 2** (9 December 13.30-15.30) will address progress and opportunities in strengthening legal frameworks for disasters and emergencies. This will include an appraisal of progress thus far in the implementation of the “Guidelines for the domestic facilitation and regulation of international disaster relief and initial recovery assistance,” as adopted by the 30<sup>th</sup> International Conference in 2007, noting the main factors for success, opportunities and remaining challenges. It will also look to the role of domestic law in promoting disaster risk reduction, in particular with regard to relevant commitments in the Sendai Framework for Disaster Risk Reduction. It will finally highlight findings about gaps in domestic law related to the promotion of training and delivery of first aid by laypersons.

Both sessions will have interpretation in all of the Conference’s working languages.

<sup>1</sup> Resilience: how individuals and communities exposed to adversity anticipate, reduce the impact of, cope with, and recover from the effects of adversity without compromising their long-term prospects.
