- The Movement takes a needs-based approach to migration, and supports vulnerable groups to access assistance and protection, including irregular migrants, women, people with disabilities, elderly and children, particularly separated and unaccompanied minors.
- Our approach is based on our Fundamental Principles in particular the Principle of Humanity – which requires us to bring assistance, without discrimination, to prevent and alleviate human suffering wherever it may be found.
- It is the primarily responsibility of States to protect and assist migrants in accordance with human rights law, international humanitarian law and refugee law. National Societies, as auxiliary to public authorities stand ready to assist and support States to meet the needs of migrants.
- National Societies can assist States in many ways, from providing emergency relief and basic health services, supporting the ability of migrants to restore and maintain family links, to supporting authorities in promoting longer-term social inclusion and fulfilling their obligations under international law.

BRIEFING NOTE FOR NATIONAL SOCIETIES ON MIGRATION FOR THE 2019 STATUTORY MEETINGS

Why is migration a topic of discussion at the 2019 Statutory Meetings?



In 2018, there are 41 million internally displaced people and 20 million refugees, almost 4 million stateless persons and 3.5 million asylum seekers globally. Many of whom challenges accessing basic services because of outright exclusion but also more indirect barriers including fear of arrest, detention and deportation, prohibitive high service costs and language issues.

National Societies actively support migrants and displaced communities in both emergency and longer-term programming. In 2018, the IFRC reached nearly 6 million migrants, displaced people and host communities - in all regions of the world - with humanitarian assistance, protection, advocacy and awareness raising in accordance with the IFRC Strategy on Migration 2018 -2022.





Last year States endorsed the *Global Compact for Safe*, *Orderly and Regular Migration* and the *Global Compact on Refugees*. We stand ready to support States in the implementation of the Global Compacts in accordance with the Fundamental Principles of the Movement.

At the Statutory Meetings in December, the Movement will come together to discuss issues related to migration and displacement (read the briefing note here) that impact our work.

At the General Assembly

• Strategy 2030 will be adopted, the strategy highlights Migration and Displacement as one of the five global challenges faced by the Red Cross Red Crescent Movement in the next decade.

At the Council of Delegates (2019 CoD)

• A resolution to adopt a **Movement Statement to States on Migration** and our Common Humanity

At the 33rd International Conference (33IC)

• On day two of the 33IC, a spotlight session will focus on **Migration** and **Internal Displacement:**

For **Migration**, discussion will focus on safety and access to services; preserving humanitarian space; supporting refugees' integration and self-reliance in host communities; and for **Internal Displacement**, discussion will focus on durable solutions and response in urban environments (link to briefing note here)
