I hereby confirm that I am a member of the

I am fully aware of the functions assigned to the Standing Commission by Article 18 of the Statutes of the International Red Cross and Red Crescent Movement (the Movement) and that members of the Standing Commission are elected in a personal capacity.

I confirm that I satisfy the requirements, profile and qualifications for candidates established in the Statutes and Rules of Procedure of the Movement as well as in the "Guidelines for Candidates for election to the Standing Commission of the Red Cross and Red Crescent" adopted by the Council of Delegates in 2019 (Resolution 4).

Because of my vocation of service and experience in the Red Cross and Red Crescent Movement, to which I have dedicated my entire professional life, and as a member and current President of the Standing Commission, I have decided to stand for re-election for a second and final term.
